- D. Approve contingency fund in the amount of \$14,584.73 for Foxen Canyon Landfill Reconstruction of C&D Pad (Solid Waste Project No, 828709) County Project No. 720624 Third Supervisorial District

### **Executive Summary and Discussion:**

On May 9, 2002, twelve (12) bids were opened for Foxen Canyon Landfill Reconstruction of C&D Pad. The lowest responsible bid was submitted by Papich Construction Company in the amount of \$145,847.25, which is 3.93% below engineer's estimate.
