## Recommendation(s):

That the Board of Directors:

Approve the attached Budget Revision Request (BJE 2005732) to appropriate \$35,000 from reserves from the Santa Maria Valley Flood Zone and to increase revenues by \$160,000 for a total of \$195,000 to complete the West Green Canyon Storm Drain Project.

### Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

#### **Executive Summary and Discussion:**

On May 11, 2004, your Board entered into an agreement for the construction of the West Green Canyon Storm Drain Project. In addition, your Board also entered into a Cooperative Agreement with the City of Santa Maria (City) to allow for the West Green Canyon Storm Drain Project and the City's West Main Street Trunk Line Project to be combined and constructed under a single construction contract.

The City is reimbursing the Flood Control District for all costs associated with the West Main Trunk Line Project pursuant to the Cooperative Agreement. The City has extended the scope of work of the construction contractor which has extended the duration project. Approving this budget revision request will allocate money for this fiscal year to complete the project.
