Background:

The Fiscal Years 2025-2030 Capital Improvement Program was presented to the Board of Supervisors on March 11, 2025. The approved Board action allowed General Services to refer the new CIP Projects to the Planning Commission and request analysis of these projects proposed for planning, initiation, or construction in future fiscal years for conformity with the County Comprehensive Plan per Government Code 65401 and 65402.

The applicable fiscal year 2025-2030 CIP Projects were provided to Planning and Development for review for conformity with the Comprehensive Plan. Planning and Development staff reviewed the proposed projects and provided the Planning Commission with a staff report that was reviewed and approved at the June 4, 2025, Planning Commission Hearing.
