Sheriff: Increase appropriations by \$134,360 to cover additional food service costs and overtime due to the reclassification of the Santa Maria Branch Jail to a Type II facility.

In May 2007 the Sheriff commenced a facility type reclassification project changing the Type I designation of the Santa Maria Branch Jail to a Type II facility. Anticipated increases in expenses related to ongoing operational costs, specifically food services and staffing, were discussed at the FY 2007-08 budget hearings. This revision funds the additional services and overtime staff necessary to operate the SMBJ facility at the increased Type II levels. Cost for contract food service is quoted by the Community Action Commission (CAC) at \$4.25 per meal x 39 (Jail Population) - \$165.75 per day x 334 (Days remaining in current FY) = \$55,360. It is anticipated that overtime expenditures in FY 2007-08 will increase by an estimated \$79,000 annually from \$75,000 to \$154,000.
