- A. Pending recordation of Parcel Map No. 14,783, accept on behalf of the Public the offers of dedication for Public Utility Easement purposes and authorize the Clerk of the Board to endorse Parcel Map No. 14,783 accepting said Easements as defined on said map. Consummation of the Public Utility Easements acceptance is subject to recordation of the subject Map; and
- B. Find that no new effects will occur and no new mitigation measures would be required as a result of Board's authorization to accept the offer of dedication, and therefore pursuant to CEQA Section 15162, that action is within the scope of the project covered by the Final Mitigated Negative Declaration for the "Jette" development (12NGD-00000-00018) as adopted by the Santa Barbara County Planning Commission on January 9, 2013, and no new environmental document is required.

Summary Text:

The County Surveyor's Office has reviewed Parcel Map No. 14,783 (APN 067-040-014 and 059-030-034) located at 4690 Pennell Road, in the unincorporated area of Goleta, Second Supervisorial District. Once recorded the Parcel Map will divide the above Assessors Parcels into four legal lots and create Public Utility Easements as shown on said map. The County Surveyor is satisfied that the Parcel Map is technically correct, conforms to the approved Tentative Map (or any approved alterations thereto), and complies with all applicable laws and regulations and is satisfied that all the conditions of approval for Parcel Map 14,783 have been met. After the Clerk endorses its acceptance thereon, the County Surveyor will deliver the Map to the County Recorder for recordation.

At its regularly scheduled meeting on January 9, 2013 the Santa Barbara County Planning Commission met and approved Parcel Map 14,783 and adopted Negative Declaration 12NGD-00000-00018 for the subject project.
