**Recommended Actions:**

That the Board of Supervisors:

- a) Accept a grant of up to \$125,000 from the State Alcoholic Beverage Control (ABC) to fund increased enforcement of crimes related to alcohol.
- b) Approve Budget Revision 2006978 recognizing the grant revenue and appropriating expenditures within the Santa Barbara Sheriff's Department.

**Summary Text:**

The Santa Barbara Sheriff's Department has been awarded a grant of \$125,000 from the State Alcoholic Beverage Control (ABC) to provide enhanced levels of law enforcement on crime related to alcohol. This grant will be used to conduct minor decoy operations, develop and lead training for department personnel on enforcement of ABC laws, and develop training for vendors involved in the sale of alcohol. Overtime staff will be utilized to meet the increased demand during peak holiday times and in those areas where alcohol consumption is increasing.

**Background:** Santa Barbara County has thousands of alcohol – related violations each year. There are approximately 1,280 licensees that vend alcohol in the county; 865 of these are on-site establishments and 415 are licensed for off-site sales.
