

MEMORANDUM OF UNDERSTANDING BETWEEN THE SANTA BARBARA SAN LUIS OBISPO REGIONAL HEALTH AUTHORITY, DBA CENCAL HEALTH (“MCP”) AND COUNTY OF SANTA BARBARA DEPARTMENT OF BEHAVIORAL WELLNESS (“MHP”) REGARDING SHARING THE COSTS OF RESIDENTIAL CARE AND PARTIAL HOSPITALIZATION OF COMMON MEDI-CAL MEMBERS WITH EATING DISORDERS FOR THE TIME PERIOD OF JANUARY 1, 2022, THROUGH JUNE 30, 2022

This Memorandum of Understanding (“MOU”) is entered into between MCP located at 4050 Calle Real, Santa Barbara, CA 93110, and MHP located at 315 Camino del Remedio, Santa Barbara, CA 93110, to memorialize MCP’s and MHP’s agreement to sharing the costs of residential care and partial hospitalization care of common Medi-Cal members with eating disorders for the time period of January 1, 2022 through June 30, 2022. This MOU is separate and distinct from any Memorandum of Understanding between the MCP and MHP to memorialize the individual and shared responsibilities as directed by DHCS pursuant to APL 22-003, dated March 17, 2022 (applicable to MCP) and BHIN 22-009, dated March 16, 2022 (applicable to MHP). MCP and MHP each may be referred to herein as “Party” or together as “Parties.” This MOU is effective as of May 16, 2023 (“Effective Date”).

WHEREAS the residential care and partial hospitalization services for eating disorders are recognized in APL 22-003 and BHIN 22-009 as shared responsibilities between the MCP and the MHP.

WHEREAS MHP has paid its contracted providers for providing residential care and partial hospitalization services to Medi-Cal members with eating disorders common to both the MPH and MCP, for the time period of January 1, 2022, through June 30, 2022.

WHEREAS MCP has agreed to contribute fifty percent (50%) of the claims paid by the MHP for the time period of January 1, 2022, through June 30, 2022, which have been verified for payment by the MCP.

THEREFORE

1. The Parties enter this MOU to memorialize the MCP’s commitment to contribute to 50% of the claims paid by the MHP for the time period of January 1, 2022 through June 30, 2022, reflecting residential and partial hospitalization treatment provided to CenCal Health members.
2. MCP has reviewed requested documentation from MHP of the residential care and partial hospitalization services claims paid by MHP and has verified claims for payment totaling two hundred thousand five hundred and fifty-eight dollars (\$200,558).
3. MCP will, within sixty (60) calendar days of the Effective Date of this MOU, submit a payment to MHP in the amount of one hundred thousand two hundred seventy-nine dollars (\$100,279).

Entire Agreement and Amendment

This MOU contains the entire understanding and agreement of the Parties, and there have been no promises, representations, agreements, warranties, or undertakings by any of the Parties, either oral or written, of any character or nature hereafter binding except as set forth herein. This MOU may be altered, amended, or modified only by an instrument in writing, executed by the Parties to this MOU, and by no other means.

Execution of Counterparts

This MOU may be executed in any number of counterparts. Each such counterpart shall for all purposes be deemed to be an original, and all such counterparts, or as many of them as the Parties shall preserve undestroyed, shall together constitute one and the same instrument.
