The Housing Authority of the County of Santa Barbara supports approval of the recommendations of the Montecito and County Planning Commissions to adopt the proposed zoning ordinance amendments to implement Program 2.8 of the 2015-2023 Housing Element Update. By approving these recommendations, the Board of Supervisors will be supporting amending its zoning ordinances to be consistent with State law regarding the permitting of transitional and supportive housing.

As you know, our County faces a significant shortage of affordable rental housing, particularly for very low and low income persons with disabilities. We are encouraged that the County is considering these amendments, which will simplify the approval process for Transitional and Supportive Housing to help meet the needs of these vulnerable County residents. Affordable housing with appropriate support services is vital to meeting this need.

We wish to thank the Board of Supervisors for considering approval of these recommendations and to thank County Planning and Development staff for diligently working on these proposed zoning ordinance amendments.
