That the Board of Supervisors set a hearing for June 2, 2009 to consider the appeal filed by the High Meadow Home Owners Association (case no. 09APL-00000-00003) of the County Planning Commission's January 21, 2009 denial of the appeal (08APL-00000-00026), and de novo approval, of the Old Mill Tract Access Road (08LUP-00000-00143) located at 480 Alamo Pintado Road (APN 139-250-036) in the Solvang Area, Third Supervisorial District, as follows (time estimate 1.5 hours).
