#### **Recommended Actions:**

That the Board of Supervisors:

- (a) Approve, ratify, and authorize the Chair to execute the attached Amendment No. 1 to the Agreement for Professional Legal Services between the County of Santa Barbara and Rutan & Tucker, LLP, amending the scope of work and increasing the not-to-exceed amount to \$200,000; and
- (b) Determine that the above action is not a project under the California Environmental quality Act (CEQA) pursuant to CEQA Guidelines Sections 15378(b)(4) and 15378(b)(5) because it consists of government administrative or fiscal activities that will not result in direct or indirect physical changes in the environment.

#### **Summary Text:**

The Board of Supervisors, under the provisions of Section 31000 of the California Government Code, is empowered to contract for special legal services. County Counsel recommends the assistance of outside counsel Rutan & Tucker, LLP to provide legal advice and litigation work on public construction projects, including the proposed Tajiguas Resource Recovery Project (TRRP).

#### **Fiscal and Facilities Impacts:**

Costs in connection with the TRRP would be paid by Resource Recovery.

#### **Key\_Contract\_Risks:**

The contract does not include the County's indemnity clause, however, the firm is required to and does maintain professional liability insurance. This professional liability insurance is likely to cover any malpractice claim that may arise. Even without this clause, County Counsel views this Agreement as low risk because Partners Douglas Dennington, Robert Owen, and Peter Howell with Rutan & Tucker, LLP are highly experienced and have worked successfully with other government agencies for many years.
