WHEREAS, the Legislature approved Senate Bill 163, Children Wraparound Services which became effective statewide on October 8, 1997; and

WHEREAS, the purpose of this bill is to return children and youth in group home care to their homes and communities, or help children at imminent risk of placement in high-end group homes to remain in their homes; and

WHEREAS, this legislation permits counties to use the Wraparound funding for planning and service delivery instead of for placements of children/youth in high-end group homes; and

WHEREAS, Santa Barbara will implement the SB 163 Wraparound Program utilizing a model based on a collaborative effort amongst Santa Barbara County Departments of Social Services, Alcohol Drug and Mental Health Services, Probation, and a local non-profit Medi-Cal provider that will provide key wraparound facilitation and parent partnering functions; and

WHEREAS, an Interagency Memorandum of Understanding ("MOU") has been executed by the participating Santa Barbara County Departments to establish a protocol for the implementation of Wraparound Services in Santa Barbara county; and

WHEREAS, Santa Barbara County Department of Social Services will be responsible for the administrative functions of the SB 163 Wraparound Program , including contracted services, fiscal management, training, data collection; and

WHEREAS, a separate MOU must be executed between the California Department of Social Services and Santa Barbara County Department of Social Services, as required by the State of California, for a term of three years, to make available to the County the State share of non-federal reimbursement for group home placement which the County will use to develop family-based service alternatives; and

WHEREAS, the MOU to be executed between the California Department of Social Services and Santa Barbara County Department of Social Services requires that the Santa Barbara County Board of Supervisors delegates to the Director or designee of the Santa Barbara County Social Services the authority to enter into any written amendments to the State/County MOU on behalf of the County;

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Board of Supervisors of the County of Santa Barbara hereby:

1. Authorizes the delegation of authority to the Santa Barbara County Director, or Designee, to Negotiate, Execute, Amend, and Terminate Memoranda of Understanding for the provision of Wraparound Services.
