


ADMHS Overview

- Alcohol and Drug Services to Drug Medi-Cal beneficiaries, court-ordered and grant participants




ADMHS Budget FY 11-12 \$76.2M*




Budgeted FTEs by Fund






ADMHS Clinic Staffing






Extra Help Expenses and FTE






