The infrastructure would not be able to handle the proposed increased housing between Ward Memorial hwy and Los Positas Rd.

Our Water supply has been limited and we have been encouraged to conserve water. Water will always be hard and expensive to maintain for small water companies such as Goleta Water and La Cumbrea Water districts.

We are opposed to rezoning the Glen Annie Golf Course and agricultural lands for the purpose of building affordable, low-income and extremely low- income housing. We value our green spaces and agricultural lands in and around Goleta, which once was The Great Land, then it became the Good Land. Additional residences that the County BOS is proposing in its ill-fated plan, would turn this area into The BadLands.

San Marcos Growers is a rare treasure for local native plants, which are drought tolerant and reduce our watering consumption. It is offensive to read news articles about the County of Santa Barbara targeting our treasured agricultural businesses to satisfy the State's insatiable desire for growth.
