- A. Approve plans and specifications for the Construction of Summerland Circulation and Parking Improvements on Ortega Hill Road and Lillie Avenue, First Supervisorial District, County Project No. 862256;
- B. Award the construction contract in the amount of \$1,234,993.50 to the lowest responsible bidder, Lash Construction, Inc., a California Corporation (A Local Vendor), P.O. Box 4640 Santa Barbara, California 93140, subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project and as required under California Law;
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents and the review and the approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives; and
- D. Approve a contingency fund in the amount of \$74,249.68 for the Construction of Summerland Circulation and Parking Improvements on Ortega Hill Road and Lillie Avenue, First Supervisorial District, County Project No. 862256.

Summary Text:

On Thursday, November 1, 2007 six (6) bids were opened for the Construction of Summerland Circulation and Parking Improvements on Ortega Hill Road and Lillie Avenue, First Supervisorial District, County Project No. 862256. The lowest responsible bid was submitted by Lash Construction, Subject: Construction of Summerland Circulation and Parking Improvements on Ortega Hill Road and Lillie Avenue,

Inc., a California Corporation (A Local Vendor). The lowest responsible bid was submitted in the amount of \$1,234,993.50, which was 25.6% under the Engineer's Estimate. The low bid can be attributed to the timing of the project advertisement and the start of construction in January when there are fewer construction projects. Staff has performed an analysis of the bids received and has determined that the low bid is reasonable. Staff recommends awarding this contract to Lash Construction, Inc.

This project is located between Colville Street and Evans Avenue on Ortega Hill Road and Lillie Avenue in the town of Summerland. The purpose of the project is to improve the pedestrian, vehicular and bicycle circulation by constructing curb, gutter, and sidewalks, delineating a bike lane and by adding parallel and angled parking where feasible. Road access will remain open at all times. The construction work will be limited to one side of the roadway at a time to ensure the least possible disruption to the traveling public. Traffic delays up to 10 minutes can be expected throughout the duration of the project. Construction is currently scheduled to begin January 7, 2008 and to be completed in April, 2008.

This project was bid in accordance with the Public Contract Code, which requires the award to the lowest responsible bidder.

Background:

On January 10, 2006 the Board of Supervisors approved the project and categorical exemption pursant to the County's Calfornia Environmental Quality Act (CEQA) guidelines and on August 28, 2007 the Board of Supervisors authorized the Director of Public Works to advertise for bids for Construction of Summerland Circulation and Parking Improvements on Ortega Hill Road and Lillie Avenue.

This project was included in the FY 07/08 Capital Improvement Program.
