2001/2002 General Fund Asphalt Concrete Overlay in the Town of Ballard in the Santa Ynez Valley. County Project No. 863004, Third Supervisorial District.

Recommendation(s):

Accept Notice of Completion for work performed by the Contractor, R. Burke Construction, P.O. Box 957, San Luis Obispo, CA 93406 (Not a local Vendor), and authorize Clerk to record.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project consisted of the reconstruction of Baseline Ave. from the Alamo Pintado Bridge to Lewis Street totaling 750 Lineal Feet. This segment was widened to 34 feet from the original 25 feet to accommodate the Class II Bikelanes. Drainage Improvements consisted of the installation and construction of seven (7) storm water catch basins and approximately 815 lineal feet of underground conveyance piping.

In addition, the County Maintained Streets of the surrounding area namely, Cottonwood Street, Lewis Street, and School Road received a conventional asphalt overlay consisting of a 0.07' thick asphalt concrete leveling coarse, approximately 3,600 square yards of pavement reinforcing fabric, then a final asphalt concrete coarse 0.15' thick.

The contract was accepted on December 18, 2002, by the Director of Public Works as complete.

The project was completed on time and under the budgeted contract amount.
