# Solvang, Denmark, International Friends

I am requesting some unique intervention due to some unusual circumstances that has brought me to the city of Solvang.

China mailed seeds ~~via a Taiwan shipping company~~ via a Taiwan shipping company to various countries after I delivered a suggestion for a worldwide citizens organization started by a celebrity lawyer in India. ("Taiwan Thunderstrike" is the only song I have produced due to complexities with the American music industry.

Trump's decision to run for president, the Black Lives Matter protesting, and the Ukraine invasion are items you are more likely to know about that this situation was a plausible catalyst of.

Since 2012 there have been a few well known and less known artists that have released material related to this situation. My complexities revolve around the fact I wasn't interested in signing contracts with an American music label in order to possibly produce world peace/global unity music in a greater variety of countries.

I was presented with a scenario I wasn't prepared for and have made many mistakes simply trying to resolve this. The end result being that what has transpired with myself, other artists & corporations is not something an American music label is prepared to handle.

A contract with a foreign (or other country) label could include management and publicity that can counsel and advise what is appropriate in order to produce music in multiple countries.

Part of my complexities involve compromised internet use. Forwarding this request to friend, corporation, or appropriate government entity will be greatly appreciated. Thank you for your consideration.

I did my best to prepare myself to produce music by listening to music and working with music production software over a seven year period (2003-2010).

I was going to start by producing producing a jingle I wrote for a NPO. I found an artist with a song I was interested in producing. I interacted on Facebook in 2011. Her FB/YouTube were 600/800 and around 7k, respectively. At the end of 2011 and her song "The Lucky Ones" about not working with me (see Taylor Swift's "The Lucky One" 2012) the FB/YT numbers were around 3.5/11k. She built her 800/7k over the previous 4 years and there was no measurable difference in her quality/creativity during my interaction in 2011. (Some of her old YT subs were invited)

Disappearance of Elena Cohen - unknown singer

I wanted to produce her song "Dreaming Wide Awake". "Wide Awake" was a release by Katy Perry in 2012. Katy Perry went to India a couple months before the celebrity-lawyer of India, Uma Shankar Pandey, designed the a worldwide citizens organization he called the World Association of Scholars. I have wanted to produce music for cultures around the world supporting a global holiday (world) peace/global unity. This was discussed with the unknown artist during 2011. Madonna's song "Holiday" is sampled heavily in "Taiwan Thunderstrike". Madonna looks like Katy Perry. (Note public feud with above Taylor)

Demi Lovato [redacted] the unknown singer's Facebook in 2011. [redacted] is hosting American Idol 3

Imagine Dragons, "Everyone Wants to Be My Enemy" lyrics: "the lightning and the thunder, thunder, (repeat 2x). I utilize the Chinese word for thunder in my song by 4 females, similar to D.D. "E.W.+B.M.E." My song posted previous year.

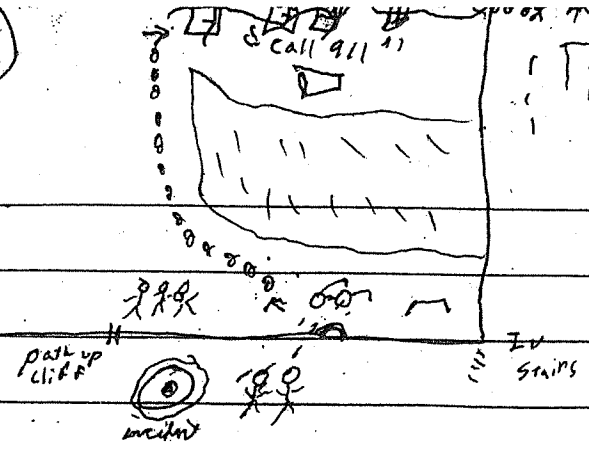
