Recommendations:

That the Board of Supervisors approve the attached Notice of Completion for the Lompoc Clinic Expansion located at 1107 E. Chestnut.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 2 Ensure the Public Health and Safety and Provide Essential Infrastructure.

Executive Summary and Discussion:

The County of Santa Barbara entered into a contract with S.J. Deferville Construction on June 24, 2003, to construct an approximately 7,600 square foot Wellness Center next to the County Health Clinic in Lompoc. The Wellness Center contains twelve exam rooms, four offices, four interview rooms, a lab room, a pharmacy, a classroom, and a large waiting area with a play alcove for children. Approximately 20 additional parking spaces, landscaping, and covered pedestrian access were added to the vacant land immediately adjacent to the clinic. The project was designed by CSA of Santa Barbara, and is a model for energy efficient design. The Clinic contains numerous skylights and is the first County building to use the groundbreaking geothermal heating system, a system which utilizes the earth's temperature to heat the building.

The project was completed on July 9, 2004 for the total contract amount of \$1,505,567, which is inclusive of the original contract amount of \$1,330,080, Amendment No. 1 in the amount of \$112, 461 approved by the Director of General Services, Amendment No. 2 in the amount of \$66,762 approved by the Board of Supervisors, and Amendment No. 3 for a credit of \$3,746. The revisions totaled approximately 13.2% of the approved contract amount. Approval of the Notice of Completion will provide for the Release of Retention.

Mandates and Service Levels:

No change in mandates. The County is mandated under Welfare and Institutions Code 17000 to provide necessary medical care to the indigent.

The Lompoc addition will allow services to increase from 29,443 annual patient visits up to 37,500 annual patient visits.

Fiscal and Facilities Impacts:

This project is funded with a combination of Tobacco Settlement dollars and Public Health Department Special Revenue Funds. Funds for this project have been appropriated and are available in Fund 0030, Dept. 063, Account 8200, Program 1930, Project 8636.
