

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE  
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA**

**IN THE MATTER OF RESCINDING** )  
**RESOLUTIONS NO. 72-1, 74-544, 78-89 & 98-2** )  
**WHICH ESTABLISHED NO PARKING ZONES** ) **RESOLUTION NO. \_\_\_\_\_**  
**ON SAN YSIDRO ROAD IN THE MONTECITO** )  
**AREA; FIRST SUPERVISORIAL DISTRICT** )

**WHEREAS**, the Board of Supervisors, on January 3, 1972, adopted Resolution No. 72-1; on July 8, 1974, adopted Resolution No. 74-544; on February 21, 1978, adopted Resolution No. 78-89; and on January 6, 1998, adopted Resolution No. 98-2, which established “no parking” zones on San Ysidro Road, in the Montecito area; and

**WHEREAS**, conditions have changed since these Resolutions were adopted and it is no longer necessary to retain “no parking” zones at these locations, and such Resolutions should be rescinded;

**NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED**, that Resolutions No. 72-1, 74-544, 78-89 and 98-2, which established “no parking” zones on portions of San Ysidro Road be rescinded at the hereinafter described locations:

No Parking

- On both sides of San Ysidro Road, between East Valley Road (State Route 192) and a point 175 feet north of the centerline of East Valley Road (State Route 192).
- On the west side of San Ysidro Road, from 175 feet north to 320 feet north of the centerline of East Valley Road (State Route 192).
- On the east side of San Ysidro Road, from a point 247 feet north of the centerline of East Valley Road (State Route 192) to a point 330 feet north of the centerline of East Valley Road (State Route 192).
- On the west side of San Ysidro Road, between a point 35 feet north of the centerline of Bolero Drive and a point 60 feet south of the centerline of Bolero Drive.

**IT IS FUTHER RESOLVED** that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to remove appropriate markings and/or signposts at said locations as time and resources permit.
