Yes. The Santa Barbara County Board of Supervisors must approve receipt of any donation over \$10,000.

4. **Describe the problem that your grant request addresses and how public safety will be enhanced across Santa Barbara County**

Time and time again, the Fire Department has experienced limitations with connectivity due to natural disasters. During the debris flow, as well as other incidents over the past few years, Fire Dept. personnel have had problems making contact due to fiber networks, hardlines, and/or power going down for long periods of time. A recent fire in Buellton shut down all connectivity to the entire valley for 48hrs, causing the Santa Ynez Valley Cottage Hospital site to go on diversion. With these incidents occurring more and more frequently, the Fire Department is in dire need of coming up with mitigations to minimize delays in emergency operations.

Trials were conducted to determine the best tool for better connectivity to limit interruptions in emergency service delivery. It was determined that switching to Starlink would be the best choice for our department.

We would like to place Starlink equipment on 17 Chief Officer vehicles, as well as on two (2) Fire Crew Superintendent vehicles.

The Starlink technology will not only better equip the Santa Barbara County Fire Department with uninterrupted emergency service delivery during fire operations, but will also be used to support local hospitals, Sheriff, community evacuations, and notifications.

We are requesting grant assistance to cover one-time hardware purchase costs, and monthly service costs for one year.

6. **Impact study:** Could you please submit a few sentences about how last year's grant had an impact on your services.

Last year's grant afforded our department the following equipment:

- Two (2) Yamaha FX HO rescue watercraft
- Two (2) Big Foot Beach Wheels heavy-duty carts
- Two (2) rescue boards with accessories
- Two (2) Swellpro waterproof drones with accessories
- One (1) DJI Matrice 30T drone w/ accessories
- One (1) DJI Mavic 3 Thermal drone w/ accessories

The drones have been utilized countless times for search and rescue incidents, including nighttime search and rescue where infrared is utilized to locate missing surfers. The drones have also been utilized on reports of Isla Vista cliff falls. The drones were also used to assist County Planning and Engineering with assessing cliff erosion in Isla Vista to determine whether properties should be red tagged.

The watercraft have also been utilized numerous times during recent flood incidents and during search and rescue efforts to locate surfers or swimmers pulled out to sea.

### **One805, Inc.**

#### **Grant Application Guidelines**

Grant applications of One805, Inc. a 501(c)(3) registered public charity, may be submitted at any time in accordance with the guidelines that follow. Funding decisions will be based on availability of funds, impact on public safety equitably across Santa Barbara County and other Advisory Council and Board considerations.

#### **Application Process**

1. If applying on behalf of your organization or public safety department, internal approval must be noted and signed by the highest ranking member/official/employee before submission.
2. Email a completed application via a PDF attachment to [kathryn.mcgurn@one805.org](mailto:kathryn.mcgurn@one805.org) for consideration.

#### **What is eligible for a One805 grant?**

Applications may be submitted for items and initiatives to a value of \$50,000 that are not covered in an existing organization's budget. Examples that may qualify for funding include safety equipment, special training, and community programs that will enhance the safety and well-being of the residents of Santa Barbara County.

#### **What is ineligible?**

Personnel expenses, education, staff salaries, standard equipment, supplies or other items typically included in an organization's budget are not eligible for grants. Initiatives executed or items used outside of Santa Barbara County.

#### **Grant Consideration Process**

Your application will be reviewed and voted on by the One805 Board and Advisory Council. Funding is dependent on available donated funds as well as the priority of your request in relation to other needs.

We will consider exceptions to our threshold as our funds allow. Items submitted above the set threshold, and not able to be met initially will be separately considered. Any needs above and beyond the grant may be resubmitted in the next cycle of applications the following year.

Your grant application will be considered open for the calendar year in which it was submitted or until it is either funded, no longer a need or declined. If declined, you will be notified within 30 days of submitting a grant application.

Vendor quotes and invoices should be valid until January 31st of the following year.

Payments are made directly to vendors and so invoices should be presented to One805 as such.
