**FIRST AMENDMENT to  
AGREEMENT FOR PROFESSIONAL LEGAL SERVICES  
between  
COUNTY OF SANTA BARBARA  
and  
LIEBERT CASSIDY WHITMORE**

The Agreement (hereinafter Agreement) made by and between the County of Santa Barbara (hereafter COUNTY) and Liebert Cassidy Whitmore, A Professional Corporation, having its principal place of business at 5250 North Palm Avenue, Suite 310, Fresno, California 93704 (hereafter ATTORNEY), fully executed on May 10, 2022 is hereby amended ("First Amendment") as follows:

**1. Section 4, "TERM" is deleted and replaced in its entirety with:**

ATTORNEY shall commence performance May 3, 2022 and end performance upon completion of services, but no later than January 31, 2023, unless otherwise directed by COUNTY or unless earlier terminated.

**2. Exhibit B, "Payment Arrangements" Section A, is deleted and replaced in its entirety with:**

For ATTORNEY services to be rendered under this Agreement, ATTORNEY shall be paid a total Agreement amount, including cost reimbursements, up to but not to exceed \$30,000.

**3. Ratifications.** The terms and provisions set forth in this First Amendment shall modify and supersede all inconsistent terms and provisions set forth in the Agreement. The terms and provisions of the Agreement, except as expressly modified and superseded by this First Amendment are ratified and confirmed and shall continue in full force and effect, and shall continue to be legal, valid, binding, and enforceable obligations of the parties.

**4. Counterparts.** This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.

**IN WITNESS WHEREOF**, the parties have executed this First Amendment to be effective on the date when fully executed by both parties.
