Accept Notice of Completion for work performed by the Contractor, C. Beecham Corporation (not a local vendor), 755 Harbor Street, Morro Bay, California 93442 and authorize Clerk to record.

### Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

#### **Executive Summary and Discussion:**

This project consisted of a new pipe and tire revetment construction along the creek banks of Salsipuedes Creek at Santa Rosa Road Bridge No. 51C-020 on Santa Rosa Road, near the City of Lompoc. However, due to additional environmental constraints imposed through the Army Corps of Engineers nationwide permit process, the work was made impossible to complete during the approved seasonal window for work activity, and the contract was thereby terminated.

The contractor was officially notified of the contract termination on October 31, 2003. The Contractor has filed a Notice of Potential Claim, and the dispute is currently being negotiated. We will approach your Board at a later date with the Statement of Final Quantities for this contract, to include proposed resolution of this claim.
