AN ORDINANCE AMENDING ARTICLE III, OF CHAPTER 35 OF THE SANTA BARBARA COUNTY CODE BY AMENDING DIVISION 4, ZONING DISTRICTS AND DIVISION 5, OVERLAY DISTRICTS REGARDING ARCHITECTURAL REVIEW PROCEDURES FOR DEVELOPMENT PROJECTS WITHIN THE OLD TOWN RESIDENTIAL/LIGHT COMMERCIAL (OT-R/LC), OLD TOWN RESIDENTIAL/GENERAL COMMERCIAL (OT-R/GC), AND OLD TOWN RESIDENTIAL (OT-R) ZONE DISTRICTS AND THE PEDESTRIAN AREA – OLD TOWN ORCUTT (PA-OTO) OVERLAY.

The Board of Supervisors of the County of Santa Barbara ordains as follows:

SECTION 1:

DIVISION 4, ZONING DISTRICTS, of Article III of Chapter 35 of the Santa Barbara County Code is hereby amended to delete Sec. 35-243.2.2, OT-R/LC Old Town Residential/Light Commercial in its entirety and renumber the remaining sections:

3. Prior to the issuance of any Land Use Permit for buildings or structures, all plans for new or altered buildings and structures shall be reviewed by the area Architectural Review Committee as to conformance with established design criteria, and subsequently shall be submitted for approval by the Board of Architectural Review as set forth in Sec. 35–329. (Architectural Review).

SECTION 2:

DIVISION 4, ZONING DISTRICTS, of Article III of Chapter 35 of the Santa Barbara County Code is hereby amended to delete Sec. 35-243.3.2, OT-R/GC Old Town Residential/General Commercial in its entirety and renumber the remaining sections:

3. Prior to the issuance of any Land Use Permit for buildings or structures, all plans for new or altered buildings and structures shall be reviewed by the area Architectural Review Committee as to conformance with established design criteria, and subsequently shall be submitted for approval by the Board of Architectural Review as set forth in Sec. 35-329. (Architectural Review).

SECTION 3:

DIVISION 4, ZONING DISTRICTS, of Article III of Chapter 35 of the Santa Barbara County Code is hereby amended to delete Sec. 35-243.4.3, OT-R Old Town Residential, in its entirety and renumber the remaining sections:

3. Prior to the issuance of any Land Use Permit for buildings or structures, all plans for new or altered buildings and structures shall be reviewed by the area Architectural Review Committee as to conformance with established design criteria, and subsequently shall be submitted for approval by the Board of Architectural Review as set forth in Sec. 35-329. (Architectural Review). Residential second units are exempt from BAR review but approval from the BAR Chair, or designee, is required.

SECTION 4:

DIVISION 5, OVERLAY DISTRICTS, of Article III of Chapter 35 of the Santa Barbara County Code is hereby amended to amend Section 35-248.3 of Section 35-248, PA-OTO Pedestrian Area- Old Town Orcutt Overlay District, to read as follows:

3. Prior to the approval of any Land Use Permit for buildings or structures, all plans for new or altered buildings and structures shall be reviewed by Planning and Development as to conformance with the requirements for a Land Use Permit, and subsequently shall be submitted for review and approval by the Board of Architectural Review as to conformance with the Old Town Orcutt Design Guidelines in compliance with Sec. 35-329 (Board of Architectural Review).

SECTION 5:

Except as amended by this Ordinance, Divisions 4 and 5 of Article III of Chapter 35 shall remain unchanged and shall continue in full force and effect.
