Recommended Actions:

It is recommended that the Board of Supervisors:

- a) Receive and file a brief update on the Coronavirus Disease 2019 (COVID-19) and Santa Barbara County's response and operations;
- b) Provide any direction, as appropriate; and
- c) Determine that the above actions are not a project under the California Environmental Quality Act (CEQA), because pursuant to sections 153378(b)(4) and 15378(b)(5) the recommended actions consist of organizational, administrative or fiscal activities of government that will not result in direct or indirect physical changes in the environment.

Summary

Staff will provide the most recent information on the status of COVID-19 cases, the County's response and RISE business activity at the Board of Supervisors' meeting.

Staff has provided updates to the Board on the status of COVID-19 every week since March 10, and has conducted press conferences every weekday. Circumstances and number of cases in the County are

changing daily with the most updated information on the Public Health information portal at <https://publichealthsb.org>.

Discussion

The Public Health Department continues to present data from their COVID-19 dashboard on the Public Health Portal that monitors State and Reopening In Safe Environment (RISE) Guide metrics. The County variance information has a green, yellow and red system to indicate how the County is doing on these various metrics and data points. One of the purposes of the dashboard is to enable the public to have information and insight on how the County is doing in general and in relation to other communities. The department also provides an update on testing, tracing, PPE, surge capacity, etc. and any updates related to a potential health order being considered and/or industry sector guidance.

The County Executive Office continues to present an update on RISE Guide changes, business industry activity and outreach efforts. Updates on Self-Certification submittals and participation in other business programs available from the County is also presented.

Background

On March 4, 2020, the Governor of California proclaimed a health emergency due to the novel coronavirus (COVID-19). On March 11, the World Health Organization declared COVID-19 a worldwide pandemic.

On March 12, 2020 the Public Health Officer and Public Health Director declared a local health emergency for COVID-19. That same day the Director of Emergency Services proclaimed a local emergency. At that time, the County did not have any confirmed cases. On March 16, 2020, the Public Health Department reported the first confirmed case of COVID-19 in Santa Barbara County. On March 17, 2020, the local declaration and proclamation were ratified by the Board of Supervisors.

On March 19, 2020, the Governor issued Executive N-33-20 which directed “shelter in place” for Californians to reduce the spread of COVID-19 and protect the public health of residents.

On May 20, 2020, the State approved the County to accelerate through the State’s Stage 2 phase of the Resilience Roadmap. The Public Health Officer issued Health Order 2020-8.2 on May 21, 2020 to accompany the approval by the State.

The County’s objectives in this public health emergency response to COVID-19 are as follows:

1. Flatten the curve – reduce spread of infection and deaths
2. Reduce overload to health care system
3. Protect health care workers and frontline responders
4. Protect other essential workers
5. Assist the most vulnerable affected by the pandemic
6. Assist with economic mitigation, reopening and recovery
7. Inform the public with accurate and timely information

Emergency Operations Center. The response effort is coordinated through the County’s Emergency Operations Center, focused on the Public Health’s efforts to mitigate the infection and reduce an overload to the health care system. The EOC is assisted by the regional Incident Management Assistance Team (IMAT) and is supporting several teams and task forces on homeless sheltering, vulnerable(senior) populations, donation and volunteer assistance, scarce medical resources and economic and community

recovery. The EOC is also spearheading multi-government workforce coordination to provide workers needed in the emergency response effort.

County Department Operations. County departments have activated their Continuity of Operations Plans (COOPs) and are prioritizing essential services, although other non-essential work also continues. To comply with the Governor's Executive Order to shelter-in-place, a majority of public counters are closed and alternative methods have been provided for the public to access County services. (A list is available on the County's website). All County employees are Disaster Service Workers and have been instructed to continue to report to work (on-site or tele-working) unless unable to do so. Departments have been instructed to follow health safety protocols for COVID-19 for any employees on-site.

Human Resources also implemented new leave policies, in anticipation of federal legislation regarding emergency employee sick leave and family leave, and developed an "emergency worker match" program to match employee and mutual aid volunteer skills with needed positions in the response.

RISE Business Activity. The County published the Santa Barbara County Reopening in Safe Environment, or RISE Guide on May 15, 2020. Within the framework of the Governor's Resilience Roadmap, the County of Santa Barbara produced a companion guide to support the implementation of the roadmap for phased reopening. The guide was developed by experts who live and work in the region, supported by feedback from all sectors of the community. Additionally, the County has developed a Self-Certification Attestation process on-line for businesses reopening under Stage 2. Businesses are required to be familiar with State Industry Guidelines, County Health Orders and the RISE Guide, complete a plan to comply and self-certify on-line.

In order to minimize the impact of COVID-19, the County of Santa Barbara has encouraged the speedy recovery of businesses, restaurants, retail and other community entities that were required to close or curtail operations under the State of California's "Stay at Home" orders. The County developed the Small Business and Community Partnership Enhancement Program (SBCPEP), a clear, quick path and parameters for businesses and other entities to operate temporarily outdoors to accommodate social distancing.

- Phase 1 of the program allows operations in the adjacent County roadway rights-of way (sidewalks and roadways) and is administered by County Public Works Department. This phase of the program began on May 20, 2020 through the Director of Emergency Services Emergency Rule #1 for COVID-19 emergency and temporarily authorizes the Santa Barbara County Public Works Director to issue encroachment permits to businesses and community entities that reopen and resume operations in County roadway rights-of-way to allow for adequate social distancing during operations. Staff is seeking the Board's ratification of this action.
- Emergency Rule #1 allows for waiver of the application or monthly lease fee for a special encroachment permit issued pursuant to the rule.
- An amendment to Emergency Rule #1 was issued to make the expiration dates of the fee waiver and the special encroachment permit consistent with the effective date and termination of the emergency rule. The termination of the emergency rule is "until December 16, 2020, or the proclaimed Santa Barbara County Local Emergency from the COVID-19 virus is terminated, whichever is earlier, or unless this Emergency Rule #1 is earlier terminated."
- Phase 2 of the program allows for operations on adjacent private property, such as parking lots and setbacks, and will be administered by the County Planning and Community Development Department. Emergency Rule #1 excludes Phase 2 of the program. The program was presented to the County and Montecito Planning Commission on June 3, 2020 and will be presented to the Board for final approval on June 16, 2020.

On May 25, 2020, the Director of Emergency Services issued Emergency Rule #2 that temporarily suspends Chapter 35 zoning regulations and permit restrictions related to wineries and tasting rooms serving food. Additionally, Environmental Health Services made available a Covid19 Emergency Food Permit for wineries and breweries that want to serve food, but do not hold a current food permit, may apply for a limited term food permit during the Stage 2 reopening by completing and submitting an application to Environmental Health Services.
