I am Penelope Hartnell. My family has owned the Hartnell Ranch, Todos Santos, on Orcutt Hill for five generations. There has been oil production on our property since 1904.

The famous oil well, known locally as Old Maud, which put Santa Maria Valley on the map as an oil producing region, was the Hartnell #1 oil well.

I am writing in support of the PCEP 96-well cyclic steaming diatomite project. Let me note that there is no diatomite production on the Hartnell Property and I will not, in any way, benefit from this new project. I write to support an outstanding operator, PCEC, as well as the continued and increased oil production that will supply additional tax revenue to Santa Barbara County and the continuation of some of the highest paying jobs on the Central Coast. PCEC also works with over 200 contractors and vendors who are employed at any one time on the Orcutt Oil Field, including the Hartnell Property. Since 1964, I have personally overseen and monitored the Hartnell interests on Orcutt Hill.
