RESOLUTION NO. 20-208

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA, GRANTING CONSENT TO THE CITY OF SOLVANG TO RENEW THE SANTA YNEZ VALLEY TOURISM BUSINESS IMPROVEMENT DISTRICT (SYVTBID) THAT INCLUDES PORTIONS OF UNINCORPORATED AREAS OF SANTA BARBARA COUNTY

WHEREAS, the City of Solvang created the Santa Ynez Valley Tourism Business Improvement District (SYVTBID) in 2010 for a five (5) year initial term and subsequently renewed the SYVTBID in March of 2015 by Resolution No. 15-961; and

WHEREAS, the SYVTBID was renewed for a five (5) year term which ends on June 30, 2021; and

WHEREAS, the City Council of the City of Solvang has requested consent to renew the SYVTBID from July 1, 2021 through June 30, 2027 to include portions of the unincorporated area of Santa Barbara County, with adoption of Solvang City Council Resolution dated November 9, 2020;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of Santa Barbara, that:

Section 1: The above recitals are true and correct.

Section 2: The City of Solvang is hereby granted consent to include portions of the unincorporated areas of Santa Barbara County in the SYVTBID, as shown on the following map, for the renewal of the SYVTBID.

Section 3: The County Clerk is hereby directed to transmit a certified copy of this Resolution to the Clerk of the City Council of Solvang.

Section 4: This Resolution is effective upon its adoption.


