SUBJECT: Ongoing Grants for Public Health Department FY 2006-07

Recommendation(s):

That the Board of Supervisors:

- A. Authorize the Public Health Director to execute the 42 ongoing grants for the Public Health Department approved by the Board with the FY 06/07 budget.
- B. Authorize the Public Health Director to execute any amendments to the grants that are within 10% of the amount approved with the budget.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1 An Efficient Government Able to Respond Effectively to the Needs of the Community

Executive Summary and Discussion:

The Board has established a process for the expeditious execution of ongoing grants. In this process, the Board authorizes the County Executive Officer (CEO) to approve and execute ongoing grants that are included in the proposed budget. Departments submit a list of ongoing grants that is generated from the Grant Management System (GMS). Once the budget is approved, the CEO has authority to sign the grants. When the grants are sent from the State and Federal Governments, the county departments submit the grants to the CEO's office for signature.

The Public Health Department (PHD), in the normal course of business, is the recipient of numerous State and Federal Grants for a variety of programs. The list of grants that was approved with the budget includes a total of 83 grants for all county departments, over half (42) are under the PHD (see attachment A). The process to submit 42 grants to the CEO's office represents considerable staff time, both within the PHD and the County Executive Office. Rarely does the State or Federal Government require the Board or the CEO to execute these agreements.

In the interests of efficient and effective governing, the PHD requests that the Board authorize the PHD Director to execute these contracts upon their receipt from the granting agency. The approval of the recommendation before the Board will significantly reduce staff time devoted to processing revenue agreements and expedite the return of executed contracts to the State and Federal governments.

The PHD will return to the Board if during the Fiscal Year any grant increases or decreases by greater than 10% of the amount listed on the attached list and approved for Fiscal Year 06/07.

Mandates and Service Levels:

This request does not impact mandates or service levels.

Fiscal and Facilities Impacts:

The funding provided by these Agreements and their related appropriation is contained as part of the Public Health Department's Adopted FY 06/07 Budget.

This action will not result in the need for any additional facilities.
