That the Board of Supervisors:

- A. Approve the plans and specifications for Construction of 2009 American Recovery and Reinvestment Act (ARRA) Hot Mix Asphalt Overlay and Miscellaneous Concrete Repairs in the Second and Fifth Supervisorial Districts, County Project No. 810537;
- B. Award the construction contract in the amount of \$ 654,847.45 to the lowest responsive bidder, Granite Construction Company (a local vendor), subject to the provisions of documents and certification, as set forth in the plans and specifications applicable to the project and as required by law;
- C. Authorize the Chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller, and Risk Manager, or their authorized representatives;
- D. Approve a contingency fund in the amount of \$45,242.37 for Construction of 2009 American Recovery and Reinvestment Act (ARRA) Hot Mix Asphalt Overlay and Miscellaneous Concrete Repairs in the Second and Fifth Supervisorial Districts, County Project No. 810537.

**Summary Text:**

On November 5, 2009, the Public Works Department received three bids for the Construction of 2009 American Recovery and Reinvestment Act (ARRA) Hot Mix Asphalt Overlay and Miscellaneous Concrete Repairs in the Second and Fifth Supervisorial Districts, County Project No. 810537. Granite Construction (a California Corporation) submitted the lowest responsive bid in the amount of \$654,847.45, which is 11% under the Engineer's Estimate. This low bid can be attributed to the favorable bidding climate that currently exists. Public Works staff performed analysis of the bid and determined that it is responsive and reasonable, and recommends awarding this contract to Granite Construction Company. This project was bid in accordance with the Public Contract Code, which requires awarding to the lowest responsive bidder.

The proposed project will resurface 3.3 lane miles in the unincorporated areas of Goleta and Santa Maria. Construction will include repairs of failed pavement areas, placement of a Type-B asphalt concrete overlay over a Geosynthetic Pavement Interlayer, and asphalt concrete leveling course.

**Background:**

This project will use 2009 American Recovery and Reinvestment Act (ARRA) funds to resurface roads from the list of maintenance backlog in the County roadway system. On June 2, 2009, the Board of Supervisors authorized the Director of Public Works to advertise for construction bids, and approved the CEQA Notice of Exemptions and road rehabilitation locations. This project received the Authority for Construction approval from Caltrans on September 9, 2009. Project locations are attached for your information.
