Approve a Resolution in support of the County's application for funding from the California Department of Forestry and Fire Protection's Urban Forestry Grant Program for FY 2008/2009.

Summary Text:

The Department of Public Works is seeking Board approval of a Resolution supporting the County's application for funding from the California Department of Forestry and Fire Protection's (CalFire) Urban Forestry Grant Program for FY 2008/2009. Funding from this program will allow the Department to prepare an Urban Forestry Management Plan. Existing records and data for our 15,000 street trees will be drawn together into a single, modern database. The database will include categories of information such as: tree type, location, tree condition, condition of surrounding hardscape, and maintenance schedule. This street tree database can then be used to evaluate current conditions of the urban forest and prepare a Management Plan that directs the annual work plans of our urban forestry maintenance crew. The database can also assist the County in having better access to maintenance records when responding to trip and fall claims, as well as damage claims surrounding tree limbs which have fallen and damaged property. Funding is also included for field computers which would allow our urban foresters to access the street tree database for baseline information on the areas where they work, and to update the database directly from the field on their maintenance activities and other observations regarding the urban forest and adjacent hardscape.

Background:

CalFire issued a call for projects under the State's Urban Forestry Program. Funding for this program is from Propositions 40 and 84, passed by the voters in 2002 and 2006, respectively. Eligible jurisdictions from across the state may apply in a competitive process. The Urban Forestry Program will pay for up to 50% of the cost of the Management Plan with local jurisdictions funding the remaining 50%. If your Board approves the attached resolution, the County will submit an application in the amount of \$48,000 to be reimbursed by this grant. If the County receives an award of funding, the County's existing Measure D Transportation sales tax revenue would provide the necessary matching funds to complete the project in the amount of \$48,000.

WHEREAS, WHEREAS, the Governor of the State of California, in cooperation with the California State Legislature, has enacted Propositions 40 and 84, which provide funds to the State of California and its political subdivisions for urban forestry programs; and

WHEREAS, the State Department of Forestry and Fire Protection has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing application by local agencies and non-profit organizations under the program, and

WHEREAS, said procedures established by the State Department of Forestry and Fire Protection require the applicant to certify by resolution the approval of application before submission of said application to the State; and

WHEREAS, the applicant will enter into an agreement with the State of California to carry out an urban forestry project.

NOW, THEREFORE the Board of Supervisors does resolve as follows:

- 1. Approves the filing of an application for "PROPOSITION 40 and 84" urban forestry grant program funds.
- 2. Certifies that the County has or will have sufficient matching funds to complete the project.
- 3. Certifies that funds under the jurisdiction of the Board of Supervisors are available to begin the project.
- 4. Certifies that the County will expend grant funds prior to March 31, 2011.
- 5. Appoints the Department of Public Works, Scott D. McGolpin, Director as agent of the Board of Supervisors to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, amendments, payment requests and so on, which may be necessary for the completion of the aforementioned project.
