HEARING - Consider recommendations regarding the feasibility of a Montecito Area Planning Commission and Montecito Board of Architectural Review, as follows: (EST. TIME: 1 HR.)

- a) Determine whether to establish an initial Area Planning Commission (APC) and Board of Architectural Review (BAR) for Montecito;
- b) If established, determine if the authority of the APC will include full Zoning Administrator and Planning Commission jurisdiction or be limited in scope;
- c) If the APC and/or BAR are established, direct staff to return to the Board with the necessary ordinances and other procedural matters regarding implementation;
- d) If established, determine whether the funding source for the APC will be General Fund and/or increased permit fees for the APC applicants; and, if permit fees, direct staff to return with appropriate fee resolutions;

e) If the APC is established, direct staff to return in two years with an evaluation of its effectiveness and proposed criteria for establishment of APCs.

# COUNTY ADMINISTRATOR'S RECOMMENDATION: POLICY

A motion was made by Supervisor Schwartz, seconded by Supervisor Gray, that this matter be Acted on and continued, as follows: a) Conceptually approved the establishment of an Area Planning Commission and Area Board of Architectural Review for Montecito, as a pilot project, assuming appropriate funding is identified.

- b) Determined that the Area Planning Commission for Montecito will include full Zoning Administrator and Planning Commission jurisdiction with the exception of region-wide issues, such as affordable housing, regional transportation, and solid waste. The Area Planning Commission would have advisory responsibilities in issues of region-wide significance.
- c) Directed staff to return to the Board on June 4, 2002 with necessary ordinances and other related procedural matters.
- d) Directed the County Administrator to report to the Board during Budget Hearings with a cost analysis and funding options as requested by the Board.
- e) If the Area Planning Commission and Area Board of Architectural Review are established, directed staff to return to the Board in 2 years from inception of operations with an evaluation of effectiveness and performance measures. The motion carried by the following vote:
