PUBLIC HEARING )

WHEREAS, Laguna County Sanitation District established Improvement Zone No. 1 pursuant to Health and Safety Code 4850 and adopted Resolution 06-311 on October 10, 2006 to collect benefit assessments from owners of lots in proposed Tract 14,556 that would benefit from the use of a public sewer lift station used specifically for the tract; and

WHEREAS, Tract 14,556 was subsequently superseded by Tract 14,812 and redesigned to utilize private individual sewer lift stations negating the need for a public sewer lift station and use of an improvement zone to pay for its costs; and

WHEREAS, the Laguna County Sanitation District desires to abolish Improvement Zone No. 1 pursuant to Health and Safety Code §4858.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED as follows:

1. That the foregoing recitations are true and correct.
2. The date of February 8, 2022 is hereby set as the date for the public hearing described in Health and Safety Code 4854. At or before that hearing, any interested person may file a written objection to the abolishing of the zone. At the hearing the Board shall hear and pass upon all protests and objections. At the conclusion of the hearing, the Board may order that the zone be abolished.


