- A. Adopt the attached Resolution (Attached) to accept the terms and conditions of the Grant Agreement with the California Coastal Conservancy (Conservancy); and
- B. Authorize the Public Works Director to enter into a Grant Agreement for \$150,000 and any subsequent agreements with the Coastal Conservancy regarding this project and the receipt of funding.

Summary Text:

The County Public Works Department is currently developing plans to renovate coastal access stairways in Isla Vista. This work will maintain this important public resource for the community and corrects years of damage caused by the harsh marine environment. Construction is anticipated to commence in fall 2007.

The County of Santa Barbara is leveraging \$160,000 of its own funding with the following sources: Conservancy-- \$150,000; Coastal Resource Enhancement Fund (CREF)-- \$210,000; and Shoreline Preservation Fund-- \$80,000.

Adoption of this Resolution allows the County to receive this funding from the Conservancy.

Background:

Adoption of this Resolution by the Board of Supervisors is a requirement of the Conservancy for any agency receiving Conservancy grant funding. This action will allow the County to receive \$150,000 in grant funds for the Isla Vista Coastal Access Stairways Renovation Project.
