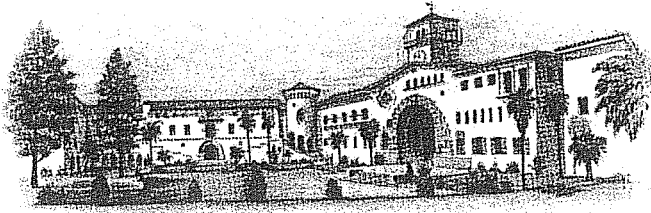

## RESOLUTION HONORING HERBERT LINVILLE FOR THE LEAGUE OF WOMEN VOTERS OF SANTA BARBARA OUTSTANDING COMMUNITY SERVICE AWARD

WHEREAS, Herbert Linville, a retired UCSB librarian, has been an active member of the League since retirement in 1988. He was born and lived on a farm in Bourbon County, Kentucky, until he went to Rhodes College in Memphis, Tennessee, for his B.A. degree, and Columbia University, New York City. He next served two years in the Marine Corps at Parris Island, South Carolina; and

WHEREAS, in December 1953, Herb moved to Santa Barbara to begin his career as a catalogue librarian at UCSB. Upon his retirement in 1988, he was head of library's Government Publications Department. Herb was an active member of the American Library Association, serving through the years in a variety of elected and appointed positions; and

WHEREAS, Herb is a long-time member of the First Presbyterian Church, Santa Barbara, serving as an Elder and a Deacon, and for many years in various offices of the Presbyterian Church (U.S.A.) at district and regional levels. In the Santa Barbara community, Herb has served as a volunteer, since their inception, with Transition House and the Community Kitchen, providing help for Santa Barbara's homeless. In 2002, Herb moved to the Valle Verde Retirement Community and has continued a volunteer locally and at Valle Verde; and

WHEREAS, for 18 years Herb has been the steady driving force behind the delivery of the Channel Voter by heading up the Mailing Team. The Channel Voter goes out 8 times a year. It is printed, addressed and mailed by the hard-working Mailing Team. It is an indispensable part of the League's community work; and

WHEREAS, Herb will be honored as an Outstanding Member of the League of Women Voters at the League's Annual Garden Party on May 9, 2009.

NOW, THEREFORE, IT IS HEREBY ORDERED AND RESOLVED that this Board of Supervisors commends Herbert Linville's important contribution to the community as an Outstanding Member of the League of Women Voters.
