PLANNING COMMISSION HEARING OF MARCH 14, 2007

Hearing on the request of the Office of Long Range Planning to review the list of new capital projects added to the 2007-2012 Five Year Capital Improvement Program (CIP) and report to the Board of Supervisors as to their conformity with the Comprehensive Plan pursuant to Government Code Sections 65401 and 65402.

Dear Honorable Members of the Board of Supervisors:

At the Planning Commission hearing of March 14, 2007, Commissioner Smyser moved, seconded by Commissioner Valencia and carried by a vote of 5-0 to recommend that the Board of Supervisors:

- 3. Request that the Office of Long Range Planning forward the list of projects that may need future review under G.C. 65402 (Attachment C of the staff report dated February 23, 2007) to affected County Departments.
