Summary Text:

The California Department of Veterans Affairs (CalVet) requires counties participating in funding programs offered through the State to meet certain criteria, as set forth in the County Subvention and Medi-Cal Cost Avoidance Programs. Two documents are prerequisites to obtaining State funding for programs addressing the needs of veterans and their beneficiaries residing within Santa Barbara County.

The Annual Subvention Certificate of Compliance specifies that the County has appointed a County Veterans Service Officer in accordance with the California Code of Regulations, Title 12, Subchapter 4, and complies with the regulations required by CalVet to receive Subvention funds.

The Annual Medi-Cal Cost Avoidance Certificate of Compliance specifies that the County has appointed a County Veterans Service Officer in accordance with the California Code of Regulations, Title 12, Subchapter 4, and complies with the regulations required by CalVet for funding this program.
