WHEREAS, it is in the best interest of public safety that certain portions of County highways in Santa Barbara County are designated as angle parking zones, in accordance with said Sections; and

WHEREAS, the Board of Supervisors on January 29, 2019 adopted Resolution No. 19-22, which established angle parking on Alamo Pintado Avenue in the Los Olivos area; and

WHEREAS, conditions have changed since the adoption of this Resolution and it is now in the best interest of the public to revise this angle parking zone;

NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED, Resolution No. 19-22 which established angle parking on Alamo Pintado Avenue in the Los Olivos area at the following location is rescinded:

• On the north side of Alamo Pintado Avenue between a point 56 feet west of the centerline of Grand Avenue and a point 227 feet west of the centerline of Grand Avenue.

IT IS FURTHER RESOLVED AND ORDERED, that the following location in Santa Barbara County and under the jurisdiction of the Board of Supervisors of said County is hereby designated as an angle parking zone and that the Director of Public Works of the County of Santa Barbara is hereby authorized and directed to install and maintain appropriate pavement markings and signs at the following location:

## **Angle Parking Zone**

 On the north side of Alamo Pintado Avenue from the centerline of Grand Avenue to the centerline of Nojoqui Avenue.

IT IS FURTHER RESOLVED that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to install appropriate markings and/or signs at said locations as time and resources permit.
