As the General Manager of Alma Rosa Winery, a large land owner and vineyard owner and producer of iconic wines in the Santa Rita Hills, I am writing to express my hope that you vote against the passage of the new winery ordinance as currently drafted.

The proposed revisions to the ordinance are highly restrictive and interfere with the successful development of wine tourism in Santa Barbara county.

The wine business is highly competitive and on site vineyard tasting experiences that create lasting impressions are necessary to differentiate a brand to create lifetime wine club members. Wine clubs and direct to consumer sales are essential to the financial viability of 95% of these small family driven businesses. Making it extremely difficult to engage visitors on the property puts the entire region at a competitive disadvantage with competing wine regions (Paso Robles, Sonoma, Santa Lucia Highlands to name a few). We already see that differential through lesser value spent on tasting room visits and lower conversion rates into Wine Club members compared to every other wine growing area with wine tourism.



Dear Supervisor Doreen Farr:

I, as the daughter of the proprietor of Refugio Ranch Vineyards, as well as the Tasting Room and Wine Club Manager of Refugio Ranch, strongly urge you to vote against the Draft Santa Barbara County Winery Ordinance as written on Tuesday, November 1st.

Below are some of my concerns with the draft winery ordinance as written.

- As a small winery that produces less than 5000 cases annually, we struggle to find adequate wholesale avenues that can help us drive revenue. Thus, we focus much of our efforts on driving direct to consumer sales to make our business work. Our customers want to see our vineyard, walk in the vines, understand where our wines come from (all of our wines are grown directly on our Santa Ynez property, we don't source from elsewhere). If you slowly take away our right to do this, our ability to maintain our business (which is struggling as it is) becomes impossible.
- I'm still confounded by how a small handful of complaints, largely related to traffic conditions in this area, has led to an ordinance that expressly seeks to restrict wineries, and does not deal with the traffic issues brought to the table. When a majority of traffic/accident issues happen from 10p to 3a and have been found to involve young members of the local population, it is obvious to me that the issue is far less about added traffic during the daylight hours that wineries bring, and much more about road safety and local education. Our young people will continue to get in accidents this ordinance does nothing to address these concerns.
- The environmental impact report was shown to have a number of errors and flaws (i.e. listing tasting rooms that have never existed). At one of the hearings that I attended, the only basis the planning committee had for the seemingly arbitrary figures they state in the new ordinance was this environmental impact report. And still there was no clear explanation to the board of supervisors or to those in attendance from the local community where these figures came from. To base an extremely prohibitive ordinance largely on a flawed report is negligent government.
