Background:

Alisal Fire Damage Repair Refugio Road, Project No. 820786

This project included construction repair of a soldier pile retaining wall to support and reestablish the failed shoulder and roadway to the pre-Alisal Fire roadway condition.





Padaro Lane Summerland Coastal Access Improvement, Project No. 862419

This project enhanced multi-modal transportation access to Loon Point Beach, and provided additional means of coastal access. The project constructed sidewalk and an equestrian trail improvement along Padaro Lane with connection points to the Loon Point Beach Parking lot and coastal access trail.

North Refugio Road Trail Restoration Phase Project No. 862427

The project included installation of a pedestrian path along North Refugio Road from Stadium Drive to Deer Trail Lane.



Sagunto Street Sidewalk Infill, Project No. 862431

This project constructed sidewalk access on the north side of Sagunto Street from Meadowvale Road to Edison Street. The project also included the reconstruction of the roadway adjacent to the sidewalk to ensure proper water flow on the street.
