# Summary

- Receive a report from staff and award a contract in the amount not to exceed \$170,000 to TriWest Group, LLC (TriWest) for the purpose of providing consulting services and assessment of:
  - Project 2:
    - The ADMHS outpatient system and service for delivery for adult and children system of care, clinic operations and contract provider services and recommendations on service delivery models vs. current facility service model;
  - **Project 3**:
    - The business practices of ADMHS' systems considering compliance with all state and federal guidelines.

### **RFP Process & Evaluation**

Review of proposals, firms ranked via a weighted system assessing overall response to RFP and ability and experience to perform services requested.

> Top 5 firms were interviewed to gain a more thorough understanding of capabilities.

> > Two firms were selected to address the projects/services requested in the RFP.


