Dear District Attorney's Office,

My name is Benjamin, I live in Berkeley, CA and I have been attempting to have some form of help with a criminal / injury concern for a very long time. This has been something that I have been attempting to do for over a year. I do not think that I can be any louder. The local DA's office has not been responsive, nor has my district representative. I am worried that there might be some form of bias involved with this. I was targeted, followed, harassed, and then injured very badly while a student in the area, first at Berkeley City College and then after transferring to the University of California, Berkeley. I know for certain that this was a deliberate targeting, I know what some of these people look like from repetitive encounters, and I have overheard conversations which indicated that this was premeditated and intentional. Despite this, I have had no help whatsoever, and am still both living with the injury and stuck pursuing a fair and legal claim for the series of injuries. Some of these have been life-threatening.

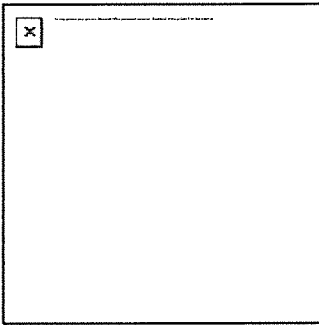
I am aware that I am somewhat known on sight by certain parties in San Francisco, but the reason for this, initial reason for this and my perspective on all of this has never been fairly discussed. I think that there was a point in time where some very affluent people were considering picking me up for something major, or otherwise willing to lend some form of support as I continued to build my own career. I believe that certain representatives from the city of Berkeley, CA and the University actively interfered with all of this, set this up to fail, and to fail publicly. I had stayed at the Courtyard Marriott in San Francisco Union Square during the week of October 19th, 2020 during the middle of this. People from Berkeley were seen there while I was there, and at one point the fire alarm was pulled. I think that this was a signal. I am sure that this can be checked. I was never spoken to about any of this, and I had no context at the time. I have very mixed feelings about all of this.

I need help in finding a way to begin to address all of this formally and within a formalized environment. I have again been seeking this for over a year, and my entire life and everything that I care about within life is on the line for this. Resolving this involves everything that matters in my life. My main priority is in resolving this into a legal financial compensation, Tort compensation, for life damage and personal injury.

Discrimination w. Traumatic Brain Injury as a Personal Injury. There has also been Medical Malpractice, Intentional Affliction of Emotional Distress, and Assault w. a Deadly Weapon. There is a lot involved with this once the mechanism is named. I think that I have found this. I also need to make sure that I can be safe from further harm. Both of these intents are I think very normal for any self-respecting adult. I am both an intelligent and self-respecting adult. There was and has been a lot involved with this which I need to be able to go over with some form of authority figure. Due to the complications of affluence, higher levels of technology, personal damages, and potential criminality, it feels appropriate to reach out to this office from Berkeley in order to request assistance. It has felt as if I had been targeted by the entire county, by both the city of Berkeley and Oakland, CA within Alameda county. As of now I still have a lease in Berkeley, CA, but need to be able to have some direct and in-person assistance with all of this. I am also worried about my phone calls and emails being filtered and intercepted. I am not certain that I have been able to receive all communications sent.

Certain words used, such as 'lesson learned', 'rescinded', 'there's no un-rescinded', and others are very criminal here. There seems to have been an intent to permanently "descend" me into hell. I think that 'rescinded' may refer to a bid on my personal rights and freedoms at a very basic level. This started during Fall 2020 and has continued since. The context of some of this has and has since hinted upon attempts at slavery, total control of life, and in attempting ownership of my body. I am worried that this might have been very literally purchased by someone, that the right to do this to me, that their perceived right to do this to me was very literally purchased by someone or attempted to be purchased. I think that people in general would be supportive if they knew all of the relevant details here, my life history, life story, and intent for future and future goals. This may or may not be relevant.

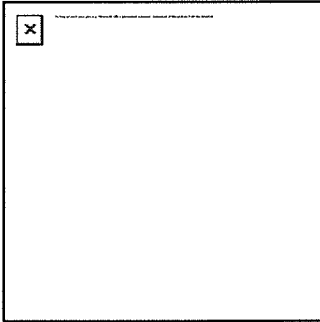
