Project Description: The activity is the Board of Supervisors' approval of a recommended County-wide process for the creation, review, approval, and monitoring of Community Wildfire Protection Plans (CWPPs). The purpose is to assist communities in creating consistent CWPPs that can be predictably evaluated and approved.

CWPPs are authorized and defined in the Healthy Forests Restoration Act (HFRA) of 2003. The HFRA provides the potential for prioritized federal funding in the form of Fire Safe Council grants for hazardous fuel reduction projects on non-federal land. CWPPs are created through a collaborative community process that brings together interested parties to identify potential hazardous fuel reduction treatments, recommend best practices for fuel reduction treatments, and recommend measures that homeowners and communities can take to reduce ignitability of homes or other structures in the wildland urban interface.

The Recommended CWPP Development Process includes preparation of a template for communities to use in developing their own CWPPs. Steps in developing a CWPP include convening decision makers, involving federal, state and local agencies, engaging interested parties, and developing community risk assessments and priorities. A final CWPP is signed by the applicable local government representative, the applicable fire department representative and the Unit Chief of the California Department of Forestry and Fire Protection.
