That the Board of Supervisors:

Accept and file the Certification of Results of the Official Canvass and Official Election Summary for the City of Guadalupe Special Municipal Election held on June 7, 2005.

Executive Summary and Discussion:

Elections Code Sections 15372 and 15400 mandate that the Registrar of Voters complete an official canvass of the election and submit the results to the governing body within 28 days. The canvass was completed on June 10, 2005. A signed and sealed Certificate of Election Results of the Official Canvass is attached (Attachment A). The same documentation has been sent to the Guadalupe City Council which is the governing board for this election.

As required by Election Code Section 15372, an Official Election Summary is attached (Attachment B) and has, also, been forwarded to the Guadalupe City Council. With the certification of the election results by the Registrar of Voters, the final date for any registered voter in the City of Guadalupe to request a recount of the results of this election is June 15, 2005 (Elections Code Section 15620).

Should any member of the Board of Supervisors or the Public want election results information by precinct, the Statement of Votes Cast for this election is available in the elections office.
