The same documentation has been sent to the Guadalupe City Council which is the governing board for this election.

As required by Election Code Section 15372, an Official Election Summary is attached (Attachment B) and has, also, been forwarded to the Guadalupe City Council. With the certification of the election results by the Registrar of Voters, the final date for any registered voter in the City of Guadalupe to request a recount of the results of this election is June 15, 2005 (Elections Code Section 15620).
