

**FIRST AMENDMENT
TO THE COMMUNITY DEVELOPMENT BLOCK GRANT
AGREEMENT**

**BETWEEN
COUNTY OF SANTA BARBARA
AND
The City Of Guadalupe**

WHEREAS, the COUNTY executed an Agreement (AGREEMENT) between the County of Santa Barbara (COUNTY) and the City of Guadalupe (OWNER), on August 27, 2014 and numbered BC14194 pursuant to the Community Development Block Grant program from the United States Department of Housing and Urban Development ("HUD") under Title I of the Housing and Community Development Act of 1974, as amended (HCD Act), Public Law 93-383 (42 U.S.C. §§ 5301 et seq.); and the regulations promulgated thereunder (24 CFR Part 570) ("Regulations"); and

WHEREAS, the OWNER is carrying out an eligible project known as the Guadalupe American Legion Hall (PROJECT), which involves seismic retrofit work; and

WHEREAS, the OWNER could not commence the PROJECT until the COUNTY completed a HUD-required Environmental Review; and

WHEREAS, the COUNTY completed the Environmental Review March 11, 2014 and the PROJECT may now commence; and

WHEREAS, the Term of the AGREEMENT is described per Section II of the AGREEMENT as ending on June 30, 2014; and

WHEREAS, the OWNER AND COUNTY mutually agree to extend the Term of the AGREEMENT.

NOW, THEREFORE, it is mutually agreed by the OWNER AND COUNTY that the Term of the AGREEMENT be extended to December 31, 2014.

Except as set forth hereof, this First Amendment shall not modify or change any of the provisions of the AGREEMENT and the parties to the Agreement are bound by its provisions, as amended herein.




