

FIRST AMENDMENT TO THE AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR  
WITH BENGAL ENGINEERING, INC., BC 17232

**THIS AMENDMENT** (“First Amendment”) is made to the Agreement for Services of Independent Contractor with Bengal Engineering, Inc. (“Agreement”, BC 17232) and is hereby made by and between the County of Santa Barbara, a political subdivision of the State of California (“COUNTY”) and Bengal Engineering, Inc. (“CONTRACTOR”) (hereinafter collectively, the “Parties”).

WHEREAS, the Parties entered into an Agreement for Services of Independent Contractor signed into effect on December 13, 2016 (“Agreement”) in connection with engineering consulting services and;

WHEREAS, the Agreement was for a term starting December 13, 2016 through December 12, 2018 and;

WHEREAS, additional time is necessary to extend the term of these agreements from December 13, 2018 through December 12, 2020 and;

WHEREAS, the Parties now hereto desire to amend the Agreement to extend the term.

NOW THEREFORE, in consideration of the mutual covenants and conditions contained herein, COUNTY and CONTRACTOR agree to amend the Agreement as follows:

1. Section 4 of the Agreement is deleted and replaced in its entirety as follows:

CONTRACTOR shall commence performance on December 13, 2016 and end performance upon completion, but no later than December 13, 2020 unless otherwise directed by COUNTY or unless earlier terminated.

2. Effectiveness of Agreement. Except as explicitly modified by this First Amendment, all of the terms and provisions of the Agreement and all previous modifications and amendments, if any, are and remain in full force and effect.
3. Counterparts. This First Amendment may be executed in several counterparts, all of which taken together shall constitute a single Agreement between the parties.


