

## SEVENTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES

Pursuant to Paragraph 26 of the AGREEMENT FOR PROFESSIONAL LEGAL SERVICES ("AGREEMENT") between the County of Santa Barbara ("COUNTY") and the Meyers|Nave law firm ("CONTRACTOR"), the COUNTY and CONTRACTOR amend the AGREEMENT as follows:

Paragraph A of the attachment to the AGREEMENT entitled "EXHIBIT B/ PAYMENT ARRANGEMENTS/ Periodic Compensation," having been amended by the Board of Supervisors on July 16, 2019, October 15, 2019, March 10, 2020, September 1, 2020, and January 26, 2021 currently reads as follows:

*For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed Four Million, Five Hundred Fifty Thousand dollars (\$4,550,000).*

Said Paragraph A of Exhibit B is hereby amended to read as follows:

*For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed Six Million, Five Hundred Fifty Thousand dollars (\$6,550,000).*

In all other respects, the AGREEMENT remains unchanged and in full effect.
