

**FOURTH AMENDMENT TO  
AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR  
BETWEEN COUNTY OF SANTA BARBARA AND THE GORDIAN GROUP, INC.**

**THIS AMENDMENT** ("Fourth Amendment") is made by and between the County of Santa Barbara, a political subdivision of the State of California ("County"), and The Gordian Group, Inc., having its principal place of business at 30 Patewood Drive, Suite 350, Greenville, South Carolina 29615 ("Contractor"), parties to the Agreement for Services of Independent Contractor signed into effect on September 22, 2015 ("Agreement").

**WHEREAS**, County and Contractor entered the Agreement for Job Order Contracting consultant services, under which Contractor agreed to perform services related to the development, implementation and support of a Job Order Contracting ("JOC") program;

**WHEREAS**, the Agreement had an initial term of one year with options to renew for up to four additional, one-year terms;

**WHEREAS**, the County has exercised three options via a First, Second, and Third Amendment and the current term of the Agreement expires on September 22, 2019;

**WHEREAS**, in the Second Amendment to the Agreement, the County and Contractor modified the Statement of Work to add additional services and revised the compensation payable to account for the additional services;

**WHEREAS**, County wishes to exercise the fourth option to extend the term of the Agreement until September 22, 2020.

**NOW THEREFORE**, in consideration of the mutual covenants and conditions contained herein, County and Contractor agree to amend the Agreement as follows:

1. **Effectiveness of Agreement.** Except as explicitly modified by this Fourth Amendment, all of the terms and provisions of the Agreement and First, Second, and Third Amendments are and remain in full force and effect.
2. **Counterparts.** This Fourth Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
3. **Term.** The Agreement's term is hereby extended for one additional year to September 22, 2020.
4. **Contract Amount.** The Agreement's contract amount of \$500,000 as described in Exhibit B, Article II, Section A, is hereby increased by \$989,858.00, for a total contract amount up to and not to exceed \$1,489,858.00.
