That the Board of Supervisors accepts the Notice of Completion for the New Cuyama Recreation Hall Renovation.

Summary Text:

This project corrected deficiencies at the New Cuyama Recreation Hall related to facility condition, code compliance, and general overall condition. The Board contract to Vernon Edwards Constructors, Inc. was awarded on October 26, 2010 and was completed on March 30, 2011. The project has been inspected and accepted as complete by the Resident Architect and the General Services Project Manager. There were ten (10) change orders. The project was completed on schedule and within budget.

Background:

The existing recreation building is 5,000 square feet; the building was generally in good condition but suffered greatly from lack of maintenance. The project corrected deficiencies related to facility condition, code compliance, and general overall condition. The project belongs to the Cuyama Valley Recreation District, and they asked the County to manage the work. The work included correcting life safety issues, ADA access improvements, and rehabilitation.

The Contractor's Bid Amount was \$402,461.00. The final adjusted cost for the extra work, Change Orders No. 1 through 10 is \$27,331.88. The total cost of the project (Vernon Edwards Constructors, Inc.) is \$429,792.88.

With approval of the recommended action, General Services will finalize the Contract with Vernon Edwards Constructors, Inc.

Narrative:

Funding for this project includes a grant obtained by the Cuyama Valley Recreation District from the State Parks and Recreation in the amount of \$220,000 which the County is managing on behalf of the District. The Cuyama Valley Recreation District is contributing \$20,702 towards the project to fund add alternate items. The remaining funds are from a Community Development Block Grant from County Housing and Community Development in the amount of \$353,766. The project costs covered by the two grants are on a reimbursable basis.
