1. Approve the attached budget revision releasing designated various fund balance to increase endowment designation and fund approved expenditures.

Summary:

The First 5 Santa Barbara Children and Families Commission seek to decrease the designated various account and increase its sustainability reserve and fund previously approved expenditures. \$786,774.00 will be moved to the endowment designation for sustainability, the remaining \$944,484 will fund approved expenditures for; Pre-School for All Program, One time cost associated with the remodel of the Santa Maria First 5 Commission Office, Outreach and Communication Implementation Activities, Insurance Premiums for children 0-5 through the Healthy Kids Program and adjust appropriation for several programs to bring them in line with the approved allocations.

Background:

The First 5 fund ended 05-06 fiscal year with a net favorable balance. This variance is primarily due to a conservative estimate of revenues received during the year, salary savings and expenditures less than projected. The current net fund balance is \$1,745,586.00; this balance is an accumulation of current and previous unreserved undesignated funds and previously designated expenditures.
