Summary:

During the agenda review process in advance of the April 24, 2007 Board of Supervisors meeting, it was determined that no Departmental Agenda hearings have been scheduled for the meeting of May 8, 2007. Three Administrative Agenda matters have been scheduled for this date; the Porter agricultural preserve contract non-renewal case 06AGP-00000-00032 and the Wickenden agricultural preserve replacement contract cases 05AGP-00000-00019 and 05AGP-00000-00020. Planning and Development staff has advised that these matters may be rescheduled for the meeting of May 15, 2007. After consultation with Chairman Brooks Firestone, it was determined appropriate to consider cancellation of the May 8, 2007 meeting. All County departments will be advised of this amendment to the meeting schedule and the Executive Office will work with departments to schedule matters for subsequent meeting dates. As such, staff is recommending that the Board cancel the meeting of May 8, 2007.
