Recommended Action(s):

Adopt a resolution establishing a "3-Way Stop" on Lillie Avenue in the Summerland area.

Summary:

Lillie Avenue is a primary collector running east and west in the Summerland area with fronting residences and businesses on the north and south sides of the roadway. The Public Works Traffic Section received several requests from surrounding residents to install a 3-way Stop at the intersection of Lillie Avenue and Valencia Road, due to high traffic volumes on Lillie Avenue. The Public Works Traffic Section staff met with the First District Supervisor and local residents at the site and it was determined that a 3-Way Stop would be installed.

The Public Works Traffic Section has prepared the attached resolution establishing a "3-Way Stop" at the following location:

The intersection of Lillie Avenue and Valencia Road

Background:

This proposed Stop control will create a 3-Way Stop, at the intersection of Lillie Avenue and Valencia Road which is currently a One-Way Stop. Future circulation plans for Summerland call for a traffic circle at this location. The proposed stop control is considered an interim measure until the traffic circle is constructed.
